

The Nursery Golf & CC first and foremost will remain a top level golfing facility.

The addition of our RV facility is a way to provide another level of service to those individuals who enjoy the RV lifestyle along with their golfing; while still providing a great golfing facility to our loyal golfing customers.

This is the overriding reason we have chosen to be primarily a seasonal RV facility as opposed to daily fee users. We hope to grow our seasonal users into a tight nit group that return year after year to enjoy the facilities as their own RV/golfing home away from home.

To this end the following will be strictly enforced for all users

RULES & REGULATIONS

ALL GUESTS

1. We are still a fully functional golf facility and therefore there is still a risk of golf balls landing in the RV area.
 - a. If golfers come looking for balls that have landed near you please be courteous we all hit bad shots
 - b. If a ball has hit you or your RV try to make note of the group responsible, and if possible get names of the individuals as they can and should be held responsible for any damages. Generally if you are calm and respectful it will be returned in kind
 - c. Let staff know ASAP and we will work toward a resolution
“PLEASE DO NOT GET INTO HEATED CONFRONTATIONS”
2. Golf Course Usage
 - a. All RV guest who wish to golf must book a time with course like any other golf patron
 - b. During regular golf hours 8am-7pm noise levels must be kept respectful as to not interfere with golfers
 - c. During regular golf hours 8am-7pm only golfers will be allowed on the golf course proper, RV’ers are not permitted to walk around on course
 - d. During off hours 7pm-sunset you are more than welcome to go for a walk on course however golfers still have priority so be aware of your surroundings
 - e. Being on the course after dark is not permitted

- f. Nursery golf carts are not allowed in RV area when you are golfing you must pick up and drop cart at proshop do not take it to your RV
- 3. Season will be May 1 until Oct 15 weather permitting
- 4. Seasonal fees will include Power, Sewer, and water for the full season, other services such as wood, laundry, etc will be at an extra charge
- 5. RV park will be strictly “trailers only” no tenting will be allowed
- 6. All RV’s must be in visually good condition as approved by Management
- 7. Quite time will be strictly enforced all music must be turned off by 11pm further socializing after 11pm must be at a respectful level.
 - a. Failure to follow this rule may be grounds for being ask to leave the facility

IT’S VERY SIMPLE RESPECT YOUR NEIGHBOURS

- 8. A max of 4 persons are allowed to overnight in a site any visitors need to be headed home by quite time 11pm
 - a. If you require an exception management must first approve
- 9. Individual sites must at all times be kept in a neat and tidy condition
 - a. Unsure you utilize garbage bins, burning it is not necessary or recommended
 - b. Green spaces (grass) will be maintained on Tuesdays ensure all impediments are removed or your site will not be cut.
- 10. RV’s and vehicles must be kept on gravel pads (no parking on grass)
 - a. Only one vehicle allowed per site
 - b. Any visitors or extra vehicles must park in overflow parking area
- 11. While there is an onsite caretaker he will not be available or on site at all times. Please ensure that personal sites are secure do not leave stuff lying around **SECURE YOUR SITE**. The Nursery will not be responsible for lost or stolen goods.
- 12. Pets must be approved by management and be on leash at all times when at facility.
 - a. Pets must be under control at all times most especially **BARKING**
 - b. Pets may not be taken on course when golfing
 - c. After regular golfing hours 7pm-sunset you are more than welcome to take your dogs for walk around course (must stay on leash)
 - d. You are responsible for cleaning up after pets
 - e. We are in the country and have coyotes in close proximity be sure to secure your pets at night

13. Laundry and washroom facilities are available on a pay per use basis and will be maintained regularly; however, please be courteous to other users and clean up after yourself, don't leave a mess for other patrons to wade through.
14. Ice and wood will be available for purchase from the caretaker. times will be posted as to when he will be available, please plan accordingly
15. Decks and Sheds will be permitted on seasonal sites. Decks and sheds must be approved by management and be constructed to be visually appealing and be maintained and neat at all times Decks may be no larger than 10' x 15' and removable. Sheds can be no larger than 10' x 10' and also non-permanent construction.
16. In case of an emergency the caretaker will normally be in or around the clubhouse during normal golfing hours
17. Any questions, concerns or complaints please advise caretaker

ALCOHOL POLICY

1. The Nursery is a fully Licensed facility so the following liqueur rules must and will be strictly enforced
 - a. Private alcohol may be kept and consumed only in your site you are not allowed by LAW on course or road ways with alcohol.
 - b. You will not be allowed to purchase alcohol from the clubhouse to take to your sites
 - c. No private alcohol may be taken when golfing, coolers are not permitted on course unless the staff has seen they have only non-alcoholic contents
 - d. These and all Liqueur laws are set by the ALCB not the Nursery Golf Course and must be followed by everyone and will be strictly enforced failure to follow these rules may be grounds for expulsion from the facility
 - e. **We do not abide drunken, disorderly, or abusive behavior by any persons, or towards any persons. Any incidence of this behavior "WILL BE" grounds for immediate expulsion from golf course and RV facilities for the offender and their entire party**
